BY INSTALLING, USING OR ACCESSING THE SERVICES OR ANY MATERIALS INCLUDED IN OR WITH THE SERVICES, YOU HEREBY ACCEPT THE TERMS OF THIS AGREEMENT. 1. LICENSE
